## SECTION (A) SUMMARY

This is the seventh report of its type. The first report covered the period from inception to 31 December 2009 with brief comments for the first five months of 2010. The second to the sixth report covered the years 2010 to 2014 respectively. This report covering 2015 is intended to be presented at the Annual General Meeting scheduled for 29 March 2016.

The main activities in 2015 related to publications and educational services. The Siddhartha Institute of Buddhism continued to provide valuable educational services.

During the year the third delivery of the course in Buddhist Chaplaincy continued and was scheduled to be completed in March 2016.

A major effort was put in to conduct a diploma level course in Buddhist psychology (Abhidhamma). This course was based on the ancient book The Treatise on Abhidhamma by Bhadantha Anuruddha which was a summary of the Abhidhamma Pitaka in Pali.

This course commenced in April 2015 and is planned to be completed in May 2016.

Another major achievement in 2015 was the printing and publication of the book Buddhist Chaplaincy written by Rahubadde Sarath-Chandra.

A breakthrough achievement in 2015 was the appointment of Venerable N. Sudhamma as a Buddhist Chaplain in the University of Queensland.

# SECTION (B) PROMOTING UNDERSTANDING AMONG THE MAIN SCHOOLS OF BUDDHISM

There were no events in this category in 2015.

# SECTION (C) EDUCATIONAL AND TRAINING ACTIVITIES

#### 1 SIDDHARTHA INSTITUTE OF BUDDHISM

The Siddhartha Institute of Buddhism was set up on 1 January 2015 to conduct all educational and training activities of QSA in the way a tertiary institution would.

The two courses mentioned in the summary above were conducted during the year. The senate continued unchanged.

The names of members of the Senate are given in the Siddhartha Institute Prospectus 2016 which can be seen on the QSA website under the menu Educational Services via the list of documents given at the end of the section.

The information pack in regard to the Buddhist Chaplaincy course is also listed at the same point.

The information pack in respect of the Diploma Course in Buddhist Psychology (Abhidhamma) can also be accessed via the list of documents under Educational Services of the QSA website.

The same list gives access to the information pack of the Diploma Course in Dhamma which is in the plans for the future.

The Siddhartha institute of Buddhism will function independently mainly for academic purposes while remaining under the administrative control of QSA in a broad sense.

# SECTION (D) PUBLICATIONS ON BUDDHISM

#### 1 BOOK ON BUDDHIST CHAPLAINCY

The book was not printed for quite some time due to inadequacy of funds. The Vice-President Venerable S. Sugathasara was successful in obtaining the support of the Body Corporate of the Buddha Educational Foundation in Taiwan to print 1000 copies of the book free of charge. The foundation bore all costs up to delivering the books to the port of Brisbane. This project was completed in November 2015 and the book is being distributed free of charge.

Mr. Kamal Wanigasuriya helped in designing the cover of the Buddhist Chaplaincy book.

An electronic copy of the book was planned to be published in March 2016 and when ready will be on the QSA website under the menu RESOURCES.

#### 2 BUDDHIST PUBLICATIONS BOARD

A Buddhist Publications Board continues unchanged.

# SECTION (E) BUDDHIST CHAPLAINCY SERVICES BOARD

The Buddhist Chaplaincy Services Board remained unchanged during 2015.

Venerable N. Sudhamma one of the Buddhist Chaplains registered with the Queensland Sangha Association Inc. was appointed as a Buddhist Chaplain in the University of Queensland. Venerable Sudhamma is closely associated with the Sri Lanka Buddhist Monastery (Brisbane) Inc. in Ellen Grove, Brisbane and is also the secretary of the Queensland Sangha Association Inc. as in 2015.

This Buddhist Chaplaincy Services Board will function independently though remaining under the administrative control of the QSA.

# SECTION (EE) GENERAL CONSULTANCY SERVICES

There were no new services rendered during the year. Small projects were handled by Rahubadde Sarath-Chandra.

# SECTION (F) DEVELOPMENT (TOWN) PLANNING (TEMPLE DEVELOPMENT) SERVICES

There were no new projects this year.

# SECTION (G) SANGHA WELFARE SERVICES

No progress was made in regard to this matter.

# SECTION (H) COMMUNITY RELATIONS

Hardly anything useful resulted from the agreements signed with the ASA (Australian Sangha Association Inc.), and the Buddhist Council of Queensland. However QSA worked closely with the Buddhist Education Services for Schools Inc. as envisaged in the MOU.

# 1 RECOGNITION AND IDENTIFICATION OF QSA AT FEDERAL LEVEL

The Queensland Sangha Association (QSA) is identified by government at the federal level by its Australian Business Number (ABN) which is 56 506 052 172. The street address is 108 Eric Street, Goodna, Queensland 4300. QSA is also registered for GST. Nothing has changed in this respect. However, there is a new federal authority dealing with business numbers. That is the Australian charities and non-profits commission (ACNC). QSA is now in their website.

There is a new requirement to file reports with ACNC every year. The first report in respect of 2014 has been filed.

No changes were made to the constitution in 2014.

# 4 INCORPORATION OF QSA

The first Annual General Meeting required after incorporation was held on 27 December 2011. From thereon, each year an AGM has been held in the early months of each year. The annual reports are filed under Resources as part of archives.
